



## CITY COUNCIL ACTIONS

**In an effort to increase community awareness and understanding, this publication was created to detail and explain the recent actions of the Huber Heights City Council through its meetings and legislative actions. This information will also further promote a better understanding of the role played by the City Council in keeping Huber Heights a great community in which to live, work, play, and visit.**

### **City Council took the following actions at the May 3, 2021 Council Work Session:**

- Recommended placing a resolution for a first reading on the agenda at the May 10, 2021 City Council Meeting to approve improvements to baffles and magnetometers at the Rose Music Center.
- Recommended placing a resolution for a first reading on the agenda at the May 10, 2021 City Council Meeting to authorize participation in the 2022 BWC Group Experience Rating Program.
- Recommended placing a resolution for a first reading on the agenda at the May 10, 2021 City Council Meeting to authorize a water service connection assessment for a property at 4517 Fishburg Road.
- Recommended placing a resolution for a first reading on the agenda at the May 10, 2021 City Council Meeting to approve the construction of a skate/BMX park at Monita Park.
- Recommended placing a resolution for a first reading on the agenda at the May 10, 2021 City Council Meeting to approve the construction of a mountain bike trail at Dial Park.
- Discussed the process for selecting a trash hauling vendor for the new contract beginning July 1, 2021 for the City's residential trash hauling services and recommended a City Council Special Meeting on May 5, 2021 to award a new contract.
- Discussed a land lease for property at Waynetowne Court and recommended further discussion on this item at an upcoming Council Work Session.
- Recommended placing a resolution for a first reading on the agenda at the May 10, 2021 City Council Meeting to approve a Memorandum Of Understanding with DDC Management, LLC for a single-family home subdivision off of Chambersburg Road.
- Discussed the next steps for the City Council in working with the Culture and Diversity Citizen Action Commission.
- Recommended placing a motion on the agenda at the May 10, 2021 City Council Meeting to approve the transfer of a liquor permit for the Pit Stop at 5701 Old Troy Pike.
- Recommended placing a motion on the agenda at the May 10, 2021 City Council Meeting to reaffirm the City's objections to a liquor permit for an establishment operating at 5478 Brandt Pike.
- Discussed the search process for a new City Manager and recommended further discussion of a Request For Proposals for an executive search firm to assist in the search process at an upcoming Council Work Session.
